**QUALITY ASSURANCE COMMITTEE OUTCOMES – SHELLEY HERRINGTON**

Reviews were put on hold due to the pandemic and were not resumed until November 2020. They focused on safety during their modified reviews in November and December 2020.

Support Plan Data

- Individuals reviewed – 115
- Receiving day services only – 8
- Receiving residential services and supports – 56
- Receiving personal care services – 51

Notable Areas

- 85% of individuals felt they knew what to do in case of an emergency
- 96% of individuals reported they felt safe in their homes and staff were nice to them
- Approximately 15% of reviews were found to have deficiencies in the area of signature approvals
- Approximately 15% of support plans did not represent the person's current support needs resulting in incomplete or inconsistent plans
- Two agencies came up with educational material to send to individuals and families to stress the importance of signing documentation

Some changes were made for 2021 allowing teams to complete interviews virtually or over the phone, but they are doing the full reviews. They are doing in person reviews as people feel safe to do so.
