These initial ideas and more shall be presented for your consideration by the LK + KMD Team to ensure that your new facility operates securely, smoothly, and efficiently, ensures a therapeutic environment, and meets all applicable code requirements and established programmatic goals:

### PLANNING, DESIGN AND OPERATIONAL OBSERVATIONS / ISSUES

Our Project Approach shall present the following tenets and planning approaches to create a successful behavioral care environment.

- Above all, create a non-institutional, normative, safe, and secure environment for Inpatients, staff and visitors, with as much natural illumination as possible.
- · Eliminate duplication of spaces or functions to minimize first cost investment.
- Envision a building organization that will improve staff utilization to reduce long term operational costs.
- Ensure that all correct interrelationships and flows of patients and staff occur along the most convenient, efficient, and safe circulation paths possible.
- Maximize ease of travel and security between the Intake/Admissions Process and transfers to Inpa-

tient Care Units, especially during periods of minimal facility staffing.

- Ensure staff safety at Nurse Stations and along restricted paths of staff circulation to shared support spaces within each Unit, or pairs of contiguous Units.
- Consider sharing nursing and staff support areas between paired units to minimize duplication, improve efficiency and facilitate immediate mutual support during times of patient crises and/or emergencies.
- Strive for balance between on-unit programs and/or central/shared spaces, to reduce duplication where appropriate.
- Study inclusion of a circulation spine or "mall" to link housing units, with shared functions accessible to patients, as medically appropriate. Creating it as a place, as part of each patient's daily journey; lighter and wider, in lieu of a narrow corridor.
- · Consider centralized administrative and office functions to service several Inpatient Care Units.
- Ensure visitor and staff safety by creating distinct and secure paths of travel from building entrances to visiting areas, staff facilities and all support spaces.
- Determine the preferred character, locations, and supervision for Family Visiting Areas; either centrally or distributed among paired Inpatient Care Units.
- Ensure appropriate observation from Nurse Stations to all Inpatient Activity Areas, as well as down corridors to individual patient room doorways and Unit emergency exits.
- · Maximize staff visibility and control of outdoor courtyards and recreation areas.
- Contemplate right-sizing dedicated outdoor recreation areas on each unit and creating larger shared/scheduled recreation areas.
- · Create security doors to separate designated small groups of Inpatients (by age, sex, or other behavioral criteria) from the general population of each Unit, for personal safety and well-being.
- · Introduce additional security doors to allow housing units to expand and contract depending on time of day, activities, and times of reduced staffing.
- Limit number of entrances so that a minimal number of security personnel are necessary to oversee a main entrance, a sallyport for patient transfers and a consolidated service entrance.

Myriad additional, equally important programming, planning and design considerations will be proposed and presented to Sedgwick County Leadership and Clinical Staff for input, consideration and decision-making during conceptual planning and design User Meetings.

### **Element of Successful Partnership - The Integrated Design Process**

We understand that the planning process may require interfaces with many agencies and departments as well as the users involved in programming and design. It is imperative that all voices are heard, all concerns are considered, and all decisions are made collaboratively in an open forum for communication.

Our team actively engages all stakeholders through an Integrated Design Process (IDP). We use this process to determine and adhere to goals for cost savings, life-cycle costs, maintenance requirements, occupant comfort, safety and functionality. Working together, we create high-performing sustainable buildings. This ability to seek interrelationships between the users, the owner/client and all technical disciplines is key to lower project construction costs and provide high quality design and long-term value.







# Hawaii State Hospital New Forensic Facility

Kaneohe, Hawaii

Project awarded to team of Hensel Phelps/KMD/G70 through a Design Build Competition among four competing teams. KMD Architects leading the planning and design, and locally based, G70 is the Architect of Record. The winning design consisted of a detailed Concept Design based on pre-design materials (program, functional program & room data sheets) prepared by a previous firm. KMD re-imagined the facility, based on stated desired outcomes. Project goals centered around a therapeutic atmosphere, secure environment and Hawaiian lifestyle.

### **Project Description**

Hawaii's State Hospital is the only publicly-funded, adult state psychiatric hospital dedicated solely to serving patients with serious mental illness. By law, the hospital must accept forensic patients from all islands, ordered to the hospital for evaluations, care, and custody by the judiciary system.

This new building design is predicated on three tenets:

- 1. A Therapeutic Behavioral Health Environment,
- 2. A Secure Facility designed to Correctional Standards,
- 3. Emphasize the "Hawaiian Culture" and Lifestyle.

Due to limited site availability, the new building includes four levels, (G,1,2,3), with each of three upper floors consisting of two, paired 24-bed housing units. The first inpatient floor houses a dedicated 24 bed Admissions Unit for assessment of new patients and a 24-bed High-Risk Unit for patients requiring specialized care, increased supervision or separation from the general population. Both require that patients remain within these units at all times; supported by dedicated program spaces, including a mini-mall for group therapy and several communicating, passive and active outdoor recreation. The four upper housing units are for routine or acute care. The treatment areas offer a therapeutic environment, individual specialized areas for activities, and a secure outdoor yard area for fresh air, recreation, walking and exercise.

For security concerns, the building is organized vertically to take advantage of its sloping site and fantastic views for all patients and staff. Three stacked floors of housing units are superimposed upon a ground level, consisting of building support, secure entry system, a medical treatment unit, gym, chapel and a unique Therapeutic Patient Mall. Patients housed in the four upper units receiving routine care are permitted to leave their housing units. They are escorted to a Therapeutic Mall which offers day long occupational, recreational and rehabilitation therapy to assist patient recovery. Treatment areas offer a therapeutic environment with secured outdoor activity courtyards.

The facility includes a secure entry/exit system to screen for contraband, highly secure outdoor activities yards with "no-climb" fencing, and clear lines of sight from the security and nurse observation areas. Secured and separate spaces for staff, enhance the safety of patients, employees, visitors, and the community. Building access is limited to three locations; the Entry Lobby for all staff and visitors, the service entry from a secure service yard, and finally an Intake Unit accessed from a secure yard for police and ambulance vehicles. Each entry includes a sallyport vestibule with access monitored and controlled by the Central Control.

Security design is crucial to the containment of patients is achieved through buffer zones between secure "no-climb" perimeter fencing and patient occupied, outdoor activity areas. Such fencing was limited to the rear of the facility, and insured perimeter security at the front of the hospital using the height and mass of the gymnasium as well as landscaped solid walls to normalize public perception.





While planning patient housing units, KMD maximized efficiencies between paired units by creating common support functions. Mirrored units share a seclusion suite, a service core with clinical support rooms and a service elevator. Nurse stations have direct sight lines to all patient circulation and are back to back for improved staff support and coverage. A public visitation suite is served by a secure elevator, bringing family members directly into the suite. Double-ended visiting rooms allow patients to enter from one side and family the other. KMD's "on-stage/off-stage" approach carries over to contiguous staff office suites, with direct access into each housing unit.

The vertically of building organization creates challenges for moving patients from upper residential units to the Rehabilitation Mall at ground level. KMD solved this dilemma by designing a custom elevator having two compartments, for patients and supervisory staff. In addition, a wide, skylit patient stair with continuous security netting encourages patients to walk between floors, under direct supervision by staff.

# UCSF Langley Porter Psychiatric Hospital & Clinics Inpatient Relocation

San Francisco, California

KMD has re-imagined a new psychiatric environment to better support the excellent care provided by UCSF-LPPH clinicians. The acclaimed Langley Porter Psychiatric Hospital has relocated and consolidated its 30-bed secure Inpatient Care Unit, Partial Hospitalization (PHP) and Intensive Outpatient Programs (IOP) within the 27,000 SF top floor of the older, mid-city UCSF Mt. Zion Medical Center.

In collocating the three programs, LPPH desired to create an environment to support its established approach for comprehensive and compassionate patient care. To accomplish such a complete model of care, all key program components (Medical, Nursing, Rehabilitative and Pharmacy) are accommodated on one floor.

At the outset, KMD was retained to evaluate three candidate sites within San Francisco; ultimately selecting the Mt. Zion location. Initial studies concluded that the 27,000 SF floorplate was of sufficient size, but of an extremely challenging floor configuration; two connected bar-shaped buildings to accommodate the three major LPPH programs. Construction was completed by late summer of 2023, with the new facility paying homage to its original name, the Langley Porter Psychiatric Hospital (LPPH).

Preliminary planning studies concluded it most advantageous to locate the bedrooms of the 30-bed Secure Inpatient Unit across the South Wing of the 7th Floor, within 18 single care rooms and 6 double occupancy rooms. The Inpatient Unit is organized around a central nurse station and 'Living Room', as well as distributed Clinical Support Functions and a Seclusion Suite. The program for Daily Activities including therapy and dining spaces for Inpatients is located along the eastern face of the long, North Wing. The latter may be closed at night for security, but Inpatients are able to move freely between the two zones during the day, under close supervision and control from the central nurse station.

Family, visitors and PHP/IOP patients enter directly into a shared reception area along the western face of the North Wing. This public entry serves the two ambulatory programs, as well as visitors to the Inpatient Care Unit, who are escorted through a controlled vestibule, with a metal detector at the security perimeter. The general parti for all three services was deemed feasible and accepted by staff.

The difficult issue of providing an outdoor recreation area for Inpatients was accomplished through the creation of a 'Porch', a large waterproofed space, outfitted with open-air safety screens at former large window openings. For patient comfort this outdoor amenity is located along the east face of the building, protected from the strong west winds.

Nearly every room enjoys a sweeping view of San Francisco. KMD's design goal to create a healing patient environment is achieved through bright, inviting and open interiors, softened by warm accents in wood. Collectively, they reinforce LPPH's three compassionate behavioral healthcare programs. Extensive consideration during the planning process ensures a ligature-resistant facility; safe and secure for patients, visitors and staff. This state-of-the-art space expands from 22 beds in the current hospital to 30 in the new LPPH, allowing the hospital to serve 40% more patients, overall.

# Wellfound Behavioral Health Hospital

Tacoma, Washington

KMD is the Design-Build Architect for this new 120-bed inpatient behavioral health facility. Placed within the existing MultiCare Allenmore Hospital Campus, Wellfound is a referral point for nine hospitals in the South Puget Sound Region incorporating comprehensive inpatient and outpatient programs and a large crisis stabilization unit designed to observe patients up to 72 hours. Wellfound Behavioral Health Hospital features 24 private rooms and 96 semi-private rooms in bed wings ranging from 12 to 24 beds. The facility is complemented with medical services provided by MultiCare on the Allenmore campus.

Our team was retained to design the new Wellfound Behavioral Health Hospital after another architect-contractor team was unsuccessful in achieving a design which fit within the project's budget constraints. With the client running behind the original project schedule when brought on board, KMD conducted a series of programming and design workshops to rapidly test the cost and feasibility of various design options. The client user-representatives were reluctant to abandon an all-private patient design which could not be supported by the project cost model. We developed a series of metrics to illustrate the impact of various design decisions including the following:

- · Overall building size · Travel distance for staff · Corridor length
- · Unit size · Percentage of area increase · Construction cost

Providing the appropriate level of ligature resistance is a complex issue which is unique to each project. It requires a detailed review since the decisions made can result in significant cost impacts. We have developed a Ligature-Resistant Feature Matrix to support this decision-making to determine which ligature-resistant items to provide. Using our client's Risk Assessment, every room in the project is first categorized by level of risk, and is then reviewed to determine which ligature resistant items are appropriate for that space.




