With no unfinished business or new business to conduct, Secretary Kerschen introduced Director of MABCD, Tom Stolz and turned the floor over to him to address the Board of the current status of the merger between Central Inspection and County Code Enforcement and how that pertains to the future of the Board.

Mr. Stolz informed the Board that both City Council and Sedgwick County Commission passed the adoption of the new Unified Code. With that adoption is the consolidation of the Electrical Board of the County and the Board of Electrical Appeals with the City. Within the next few weeks new members will be appointed. The current members will be notified if they are appointed to the new consolidated board.

Mr. Stolz said the high priority items for 2013 are:

- 1. Permit and license fees and how they correlate to the budget.
- 2. Continuing education for both internal staff and for contractors.
- 3. Revise the mission statement to reflect the consolidation of the two departments.
- 4. Look for a facility, separate from the current City or County locations, to house the combined operations and make a true one stop shop.

With no other business Board member Naylor made a motion to adjourn. Board member Kilian seconded the motion and the meeting adjourned.
