Unfinished Business

The Board was presented with the current electrical permits used by the City of Wichita and by Sedgwick County for comparison. Mr. Kerschen explained this is their opportunity to design a permit that they would like to see that is easy to fill out, but yet gives information on the type of work that is to be done. Board member Kretchmar made a motion for action to be postponed until the next meeting so the Board members can get input from other electrical contractors. Board member Naylor seconded the motion. The motion carried. 6 - 0

New Business

The Board was giving a copy of Section 110.26 of the 2011 National Electrical Code (NEC) and a copy of Figure E3405.1 of the 2012 International Residential Code and was asked to make a formal interpretation of the requirement of working clearance in front of electrical equipment. Board member Naylor made a motion that the interpretation of working clearance in front of equipment is the space starting at the front of the equipment and that space is from the grade, floor or platform to a height of 6 ½ feet or the height of the equipment, whichever is greater as per figure E3405.1. Board member Kretchmar seconded the motion. The motion carried, 6 - 0

The Board then discussed in great detail if the 2011NEC working clearances in front of panels is best to service the needs of the public. The members felt that in some situations the NEC was restrictive to the point of being a nuisance. Board member Naylor made a motion that an exception to the NEC added to the electrical resolution to allow in one- and two-family dwellings service panels located in garages or basements a footing or stem wall that is located below the electric panel shall be permitted to extend not more than 12 inches beyond the front of the electric panel. Board member Kretchmar seconded the motion. The motion carried. 6 - 0

With no other business to discuss, Board Member Nelson made a motion to adjourn the meeting. Board Member Naylor seconded the motion. The motion carried.
