**Unfinished Business**

The Board discussed allowing commercially permitted, multi-family dwelling, detached garages, to be wired using NM-B (Romex). The code does not allow separate structures that are considered commercial to be wired with this type of wiring system. Board Member Naylor made a motion to continue the requirement of section 4.2.180 of the UBTC, not allowing the use of NM wiring in multi-family detached commercial structures. Board member Lenz seconded, the motion carried 4-0.

The Board discussed the requirement for homeowner's exams to be given in English only. The Board was against allowing the exam to be administered in any other language than English, as other exams to certify electricians, are only given in English. Board Member Naylor made a motion to continue the practice of offering the homeowners exam in English only. Board Member Belknap seconded, the motion carried 4-0.

**New Business**

Mr. Nordick handed out the login credentials for the 2017 NEC online CEU class to the Board Members for review, and asked that each Member login and try out the new outline to verify that all of the security features we have required are still in place.

AYPO (at your pace online) also presented the Board Members with a new product they have designed to manage all CEU's for our jurisdiction. Mr. Nordick asked the Board to consider the functionality and value of this product for our electricians and vendors.

With no other business to conduct. Board Member Naylor made a motion to adjourn, Board Member Belknap seconded the motion, and the motion was approved (4 - 0).
