It was determined by the Board of Electrical Appeals that AFCI protection will be required for the sleeping areas of group homes, nursing homes and limited care facilities starting immediately. The two projects that had already been awarded contract, had materials purchased, or have already been completed to a point where extra costs would be incurred, will be allowed to be completed without the added requirement. It was noted that if the KSFM required them to install these devices on the two existing projects, this would be above and beyond MABCD's requirements for the stated projects.

Mr. Nordick reached out to the City of Wichita Alarm Administrator and the Wichita Fire Department for input as well as researching NFPA 72 (National Fire Alarm and Signaling Code) for clarification on requirements for agencies to be approved for fire alarm technician credentialing. It was determined by the Board that ESA would be approved as a Fire Alarm technician credentialing program.
