Unfinished Business

Blaine Wyrick of Thyssen Krupp Elevator reappeared before the Board to respond to questions from Capt. Steven Schowalter, WFD, and Deputy Fire Marshal Gregory Harlan. Concerns regarding the safety mechanisms in place in the event of an emergency were posed to Mr. Wyrick. Capt. Schowalter and Deputy Chief Harlan told Mr. Wyrick that they would take the information he provided back to their superiors for consideration.

Board Member Naylor made a motion to continue the discussion at the next regularly scheduled Board Meeting. Board Member Hawkins seconded the motion. The motion carried.

Chairman Ragland had the Board skip the 2014 National Electrical Code review at this time and move to New Business.

New Business

Eric Rogers from the IUEC Local 12, and Gregg Rogers from the EIWPF, were present to discuss House Bill No. 2301. They explained that they were promoting elevator inspection and certification of elevator mechanics statewide in an effort to increase elevator safety. They also promote a "Home Rule" status which would allow jurisdictions with regulations already in place to continue with those regulatory processes.

After a brief discussion of the proposed bill and a question and answer session for the Board, (Chairman Ragland called a recess at 3:56 p.m. with the meeting reconvening at 4:10 p.m. for review of Chapter Two of the 2014 NEC.)

With no other business to discuss, Board Member Kilian made a motion to adjourn. Board Member Nelson seconded the motion. The motion was approved.
